- 1.) Supervisor Frank called the meeting to order at 6:30pm

- 3.) Supervisor Frank opened the floor to public comments:
 - Charles Prior took the floor to discuss the updates with the water project. He handed out and presented the Board with a slideshow of the engineering and environmental reports. He provided a map of the areas contaminated with salt and where the water main will go. There is about 4600 feet of watermain without including the addition of the Atkinson Road. This includes all the hookups to residents along the way. Each resident would have their own meter. The slideshow included the breakdown cost of the project.
 - The report is being finalized and will need a decision from the Town on the next steps. There is a high chance the Town could receive Grants to help with the cost along the way. NEXT STEPS INCLUDE: setting up a meeting with the DOT to present the report and come up with a final estimate. Recommended to hold a public meeting to inform the residents involved to get their input and make them aware.

- Supervisor Frank updated the Board on COVID money. The COVID money cannot be used to pay the M & M heating bill so they put that money back into the COVID account and charged to building maintenance instead.
- Supervisor Frank will make a check out to the Town of Diana for the food pantry under the COVID money as non-profit. He will double check with Supervisor Zach Smith about the invoice before paying.
- Little League is still waiting for the money to be transferred to them from the previous committee.
- The Town is looking to put a scanner in the Town Hall for depositing checks to save on mileage due to the bank leaving town. We will be able to deposit checks only and will still need to deliver cash to the bank.
