Supervisor Frank reminded her that the board decided last month not to get a Court Clerk, he also would like to know how many towns have 2 Justices.

- Deputy Supervisor Jenack informed the board she has been in contact with Thomas Haynes from DANC concerning creating a water district for the Town of Pitcairn. Mr. Haynes is willing to come to a town meeting to provide information about creating a water district and to answer questions on the process, grants, etc. The Town of Diana will be making improvements to their water system and needs an answer from the Town of Pitcairn if we would be willing to create a district for the people in our town that are having the issues with the salt problem.
