- 1.) Supervisor Jenack called the meeting to order at 6:27pm.
- 2.) The Pledge of Allegiance was said.
- 3.) Public Comments:
  - Jane Rose took the floor to update the Board members on monthly numbers from the food pantry. There were 79 people at the food pantry last month. She must cut back on what they hand out due to the farm bill not getting passed.

- Upon that note, Councilman Jackson mentioned that there were two gift cards donated back from the giveaway. He suggested donating them to the food pantry towards food.
- Alicia Mira took the floor to discuss some community concerns. There
  have recently been a few complaints regarding a vicious dog in Pitcairn.
  Clerk Thomas informed the Board that the dog has recently bitten a
  community member and is now in the dog warden's possession and will
  be euthanized after the holding period.
- There has been another concern about a noise ordinance in the Town of Pitcairn. We currently do not have a local law regarding this. The best residents can do is to notify the law of their concerns.
- How long can a house be abandoned before something can be done about it? This question is being investigated further and will update the Board once we know more. The abandoned home in question is under foreclosure and in the County's hands.

## 4.) Code Enforcement:

- Larry has handed out a few compliance sheets this month. There will be a few homes/camps going up soon. One resident on Greenwood Road wants to build a camp. While another resident will be putting a home in on the river end of the Osborne Road.
- He checked on the ATM machines from Northern Federal at Sliders location.
- Larry will also get in touch with the resident working on the landing strip and see where he is at with his building permit.

- Superintendent McIntosh reported that all the salt and sand were put up and all done.
- It was discussed about ordering the new truck. Order now and it won't be ready for two years. He has a quote from United and Leland, budget officer, said the funds were there. The single axel truck has low miles, and it doesn't get used during the summer. It will be 10 years old and should be worth roughly \$50,000 without plow.
- He thinks maybe you could transfer the snowplow equipment to the new truck.
- Many people have shown concerns about the shoulders of the roads.
   Jerry said the shoulders of the roads will be getting done. Paverite will be the one doing them.
- We will be getting \$159,000 from the Power Authority. It will go in with the CHIPS money.

# 8.) Supervisor's Report:

- Councilwoman Hall asked about all the transfers happening in the Highway Fund. Leland took the floor to explain to the Board about the reasoning behind the transfers.
- We need to schedule a budget workshop meeting. The Board decided on Wednesday October 17, 2023 at 6:00pm.
- Dan Moyer asked each Town he works in for a one-time fee of \$1,500.00 to help with the improvements needed to keep him up to code with the NYS Agriculture & Markets. The Board would like a letter in writing for professional records. Councilman Jackson said he would contact him asking for one.
- Supervisor Jenack had a meeting between Carthage Savings & Loan, Town of Diana, and Harrisville Central School to discuss an arrangement with the bank. The offer came back as \$450.00/week divided by the three organizations involved. The Town could also have a scanner in place at the Town Hall for a \$600.00 installation fee through Carthage Savings & Loan. The Board agreed at first but then after some thought and feedback they decided against it. Councilman Jackson said he will get in touch with community bank and see what they can offer instead.
- Highway employees Chris Graham and Cadyn LaPlatney took the floor to address their concerns with NYS Retirement dues. Jessica discussed her phone conversation between herself and the retirement system. She assured them that it was being taken care of and it was on the to-do list.
- With the advancement of the pay schedule change, the Board needs to set an amount to take back each month from the employees. The Board agreed on \$25.00/month.
- Councilman Jackson mentions that there was a total of five gift cards left from the covid gift card disbursement. Three of them are awaiting to be claimed by the rightful resident. The other two have been donated back by the resident and told Councilman Jackson to donate them to someone in need. Councilman Jackson suggested they donate the two gift cards to the food pantry so that Jane Rose can use them to get items that people may need. She agreed they would greatly help and be appreciated.
